### **EX BOARD STRATEGY for the period 2004-2006**

- \* Convince the GA that the CLGE will enter into a new dimension:  
*A change of a rather static situation into a dynamic organization***
- \*The EB can be good as good as the GA is and how far the GA is willing to support the EB**
- \*Analyzing the structures of the market, education and branch organizations in the new EU member countries**
- \* Setting up a project how to bridge over into those organizations and prepare the way for those countries to join the CLGE. To be considered is to use as far as possible the available (hidden) information and network of the (personal) members of the CLGE. (Finland > Baltic countries, Poland, Slovakia, Bulgaria, Hungary etc.)**
- \*Setting up working programs in the EB in regard to the market developments, Education and EU relations, focussed on those new CLGE members from those new EU member countries and to proceed existing activities like PR ,the update of the market - and the quality report**
- \* Setting up 4 working parties under responsibility of the P and the 3 VP´s**
- \*Realization of closer cooperation and joint activities with other European Organizations like RICS and also FIG**
- \* Organizing (with other organizations like by example FIG) every second year a symposium related to the activities and developments of the geodetic branch ( e.g. Delft symposium)**
- \* To present the CLGE on branch related exhibitions in Europe, visited by participants from Europe and abroad**
- \*To schedule all those activities and realize them in this period.**

- **Professional Education**

1. The universities in EU with the study programmes on Geodesy, Geo-Surveying, Mine Surveying, Geomatics, Cartography, Real Estate Register, etc. should transform their present study periods into three-level (Bc, MSc, PhD.) study periods.
2. The course objectives of the study subjects on Geodesy, Geo-Surveying, Mine Surveying, Geomatics, Cartography, Real Estate Register, etc. at these universities should be identical in 70-85 % (25-30 % can be a reserve for any modification in subjects of the university in each EU member country).
3. Licensing procedures should be taken under consideration after five-year practice in Geodesy, Geo-Surveying, Mine Surveying, Geomatics, Cartography, Real Estate Register, etc. after study finishing.

- **Professional Practice**

1. To accept the university diploma on Geodesy, Geo-Surveying, Mine Surveying, Geomatics, Cartography, Real Estate Register, etc. of any universities with the study programmes on Geodesy, Geo-Surveying, Mine Surveying, Geomatics, Cartography, Real Estate Register, etc. from all EU member countries.

Dear exboard members

Following the call for comments i give you some ideas for our future business plan.

As I have already proposed during our meeting in Innsbruck, I think the CLGE must propose some sentences concerning several points of our profession.

These sentences could be published in two or three lines and we can develop our idea in one or two pages in our website.

For example

- CLGE supports Bologna model
- CLGE supports the creation of "ordre" for surveyors
- CLGE supports the demarcation in the field of each real estate
- CLGE supports the interoperability of geo-data
- CLGE supports the implementation of Infrastructure for Spatial

Information in each country. Otherwise I have received two proposals after a small consultation in Switzerland and I copy there the questions:

Aus meiner Warte kann ich nur zum Punkt "professional education" etwas beifügen: Mir scheint es wichtig, dass man sich über die Auswirkungen der Bologna-Konvention (Bachelor/Master-System) unterhält. Es soll ja die Mobilität der Studierenden nicht nur im räumlichen, sondern auch im fachlichen Sinn fördern. D.h. jemand mit Bachelor-Abschluss in Geologie soll einen Master in Raumplanung machen können (wie weit man sich an der ETH mit diesen Gedanken bereits auseinander gesetzt hat, weiss ich allerdings nicht). In meinen Augen ist diese fachliche Durchlässigkeit eine Chance, denn sie erweitert das Wissensspektrum der Geometer. Für die Studierenden wird es aber wichtig sein, zu wissen, mit welchen Kombinationen von Bachelor- und

Masterabschlüssen ihnen welche Chancen offen stehen. Wie steht es z.B. um die internationale Anerkennung von Geometerpatenten (seid Ihr vielleicht schon lange am diskutieren)?

Umgekehrt bin ich als Dozentin am D-BAUG froh, wenn das CLGE aus den internationalen Diskussionen auch einen direkten Input für den neuen Studiengang "Geomatik und Planung" liefern könnte (m.W. sind die Masterrichtungen noch nicht fix).

Wie gesagt, mein Beitrag ist bescheiden und ev. redundant. Du kannst ihn aber gerne an René Sonney weiterleiten oder eben bleiben lassen, wenn es nichts Neues bringt.

In the frame of Professional Education:

1) What are the actual conditions in respective countries for the mutual recognition ?

In the frame of Professional Practice:

1) To find out what is actual situation in european countries (or EU countries) as for the national legislation concerning the professional regulation (whether the profession is regulated only by state or also/or only by professional associations (chambers).

2) In relation to point 1) to find out in what countries exist some form of surveyor's chambers with obligatory membership or voluntary membership regulated by specific law, or only the voluntary professional associations regulated by general law concerning association of citizens.
