




## CLGE Seminar – Follow Up Workshop «Statute of the Geodetic Surveyors National Association»



“This workshop will be based on the outcomes of the Moscow Seminar of 24 September 2015 (agenda attached).

The exact goals of this Seminar will have been defined by Mr. Victor Kislov, President of the National Chamber of Cadastral Engineers, during its introduction, but its general aim is to analyse the current draft law about

the cadastral activities in the Russian Federation, under preparation by the Ministry of Economic Development, and its influence on the way the profession is organized.

The Seminar will give the occasion to present a benchmark of general trends and good practices in Europe.

Since the possibilities to discuss such topics in depth during seminars are not always optimal, the aim of this CLGE Workshop is to continue the discussions, to consolidate its conclusions and to formulate some valid recommendations in order to organize future geodetic work in the Russian Federation and elsewhere.

As indicated in the attached seminar program a special attention of the workshop will also go to the rights and responsibilities of professional governing bodies (state bodies, chambers, orders, associations, ...), the power of self- and co-regulation, the relation of cadastral engineers towards their governing bodies and rules of good governance for such authorities.”
