Signing the Code of Professional Qualifications for Property Surveyors



At a special ceremony in Barcelona four new countries (The Czech Republic, Greece, Spain and Russia) signed the Letter of Intent regarding the Code of Professional Qualification for Property Surveyors. The Code sets out the minimum educational and professional qualifications deemed necessary to practice as a property surveyor in the area of cadastre and land registration. In broad outline the Code stipulates five years university education in surveying (bachelor + masters); two to three years supervised experience, a professional test or examination by a competent authority and a programme of continuing professional development. This brings to fourteen the number of European countries that have become signatories, Belgium, Croatia, Denmark, France, Germany, Slovenia, Switzerland, Austria, Romania and Slovakia having already signed. Further signatories are expected in Sofia during the celebrations for the European Surveyor of the Year in conjunction with the Global Surveyors Day on 21 March 2019.

Contract signed at the CLGE GA in Barcelona



James Kavanagh provides an update on ILMS activities

James Kavanagh's excellent presentation on International Land Measurement Standard, during the General Assembly, contained a particularly interesting slide which brought together in a simple way what our profession is all about. Very often it is difficult to equate the land registration and mapping requirements of those countries with long standing land registration systems and cadastres with the needs of developing countries where land tenure is often tenuous and uncertain and mapping is inadequate, or sometimes absent altogether. This slide contains the basic elements common to property registration and mapping systems anywhere in the world and presents them in a simple and elegant way. Quoting from the ILMS document

"The final standard should be reliable, expose the risk inherent in data elements, and ensure the integrity of the due diligence process in whatever context. The land transfer and reporting standard consists of seven key elements required during due diligence to enable the process and minimise risks.

This creates a data feedback loop, where elements such as valuation can be improved as land data becomes available. ILMS also contains an agreed geospatial survey accuracy table, which for the first time outlines what is globally agreed in terms of geospatial output, its relationship to scale and achievable accuracy – an enormous milestone."

CLGE Policy



What policies should direct CLGE's activities in the future?


Future policy was a key theme of the Barcelona general assembly. The executive board is always keen to know the requirements of the national associations and be aware of the direction they would wish CLGE to travel. To that end a strategy workshop was organised as part of the GA. The use of Slido technology was a novel aspect of the workshop. It allowed delegates to use their mobile phones to rate lists of issues and proposals on a scale of 1 to 5 (5 being very important to the delegate and 1 being not important). Although this method led to speedy feedback it provided rather cold and statistical data. To a certain extent the agenda was predestined by the questions that were asked and the issues that were raised by the chair, giving delegates only limited ability to express why they considered certain matters important and other not. It also precluded the possibility of raising other issues, not on the pre-arranged list, from the floor. Some unstructured feedback did however come from the delegates at the end of each question-and-click session and among the issues raised were:

The cost and value of general assemblies and the need for twice yearly assemblies.

An emphasis on CLGE's role as an influencer on national governments in support of national associations.

The ability of national delegations to exert ongoing control over CLGE projects after their agreed initiation at general assembly.

Due to the limited time available during the workshop the incoming Executive Board has decided to ask all delegates to formulate additional remarks and suggestions in a written form before the end of the year.



New Questionnaire

European requirements for cadastral surveyor activities – 2019

The development of the questionnaire, prepared under the guidance of vice-president Vladimir Tikhonov, on the European requirements for property (cadastral) surveying activity, is reaching the point where it is almost ready for publication. A Survey Monkey version of the questionnaire has been developed and is currently undergoing testing.

This questionnaire is designed to gather and analyse information on the activities of surveyors involved in surveying and mapping in the context of property and cadastral surveying, specifically surveying and mapping for property registration, across the 40 member states of CLGE. It is an updating and enlargement of a similar questionnaire and report carried out in 2008. The information garnered from the questionnaire replies will provide a detailed snapshot of the state of the surveying profession across Europe as well as feeding in updated information to CLGE's Dynamic Professional Knowledge Base (DPKB) which will also be reinvigorated as part of CLGE's website redesign.
