Annex 1

Article 12 of the CLGE Statutes, Excerpt on Interest Groups, version proposed by the Belgian Lawyers but postponed during the Paris GA, 10 November 2023

Green: addition but good

Yellow: neutral addition, describes the existing process

Red: addition, not in line with our current processes or experiences

Blue: IG-PARLS proposal during the meeting of 04 January 2024 subsequently approved by the lawyers, and then finally approved by CLGE and IG-PARLS, respectively on 21 and 22 March 2024, to be proposed to the CLGE General Assembly.

Interest Groups

An interest group, representing the publicly appointed and regulated liberal surveyors is established.

Membership of an interest group is requested either by an individual declaration of a CLGE Delegate or by the nomination of a representative by a national liaison group and it requires acceptance by the interest group.

The interest group may have its own internal rules in accordance with these Statutes and CLGE's Internal Rules, to be adopted by the General Assembly.

The interest group may carry out any type of activity of interest to the Association. It has no legal representative or legal decision-making powers.

The interest group presents its activities to the Executive Board, which validates them internally in order to make them applicable.

The Executive Board may expressly and unequivocally entrust the

interest group to hold separate financial responsibility/account inside the CLGE accounts. In this respect, the Executive Board shall ensure that any such decision is notified to the members of the Association. The CLGE Treasurer has the only right of disposal of funds following the interest group's formal decisions taken under the delegated authority of the Executive Board.

Duly authorised by the Executive Board, the interest group has the right at the request of the Executive Board to raise financial contributions from its members to fulfil its financial obligations like travel costs, administrative activities, and any special commitments. CLGE excludes liability for all non-authorized obligations.

The CLGE Treasurer is also the treasurer of interest groups.

The reimbursement rules are the same as for the rest of the CLGE.

The General Assembly may establish two additional 'Interest Groups' committing themselves to represent 'the Public Service' or 'Science/Universities including Students' affairs.
